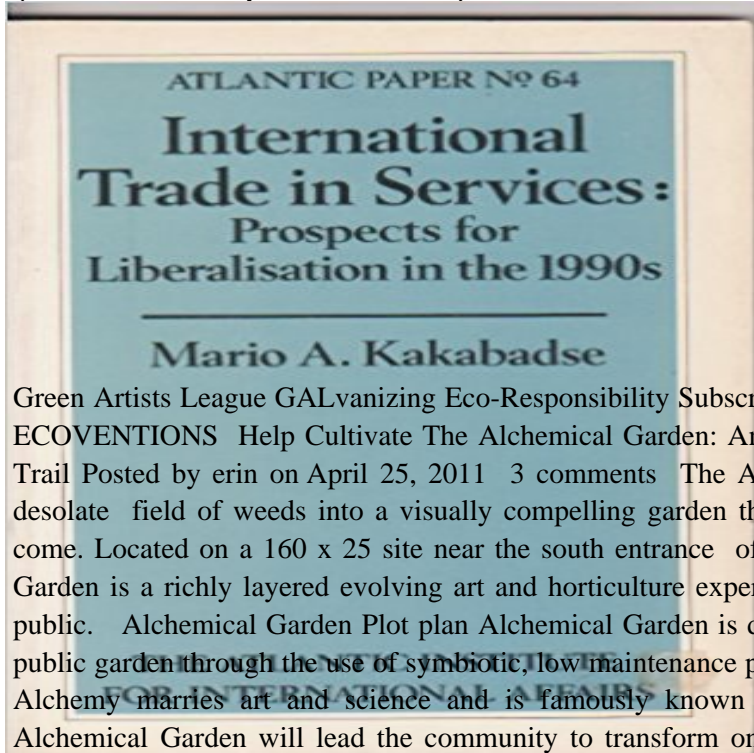


International Trade in Services: Prospects for Liberalization in the 1990s (Atlantic Papers No 64)
