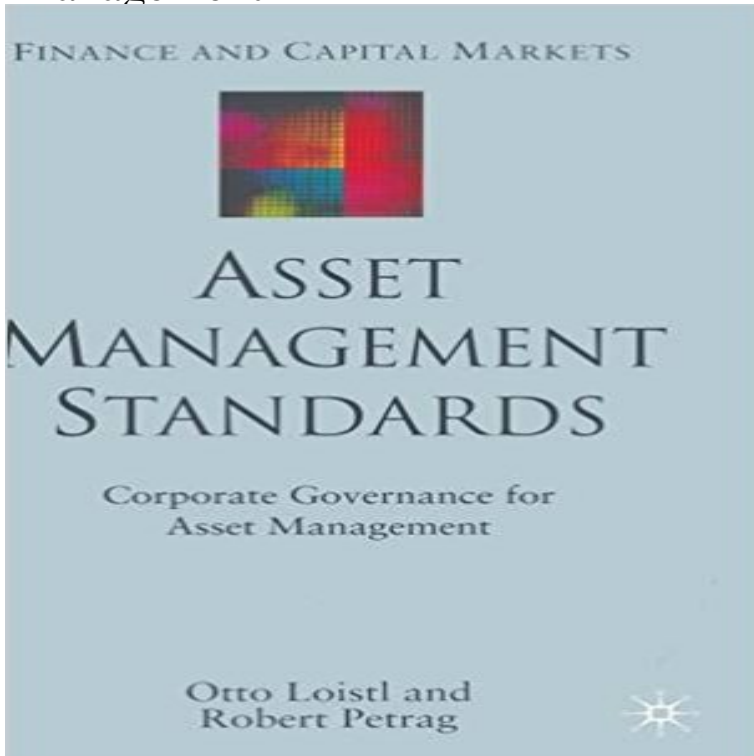


# Asset Management Standards: Corporate Governance for Asset Management
