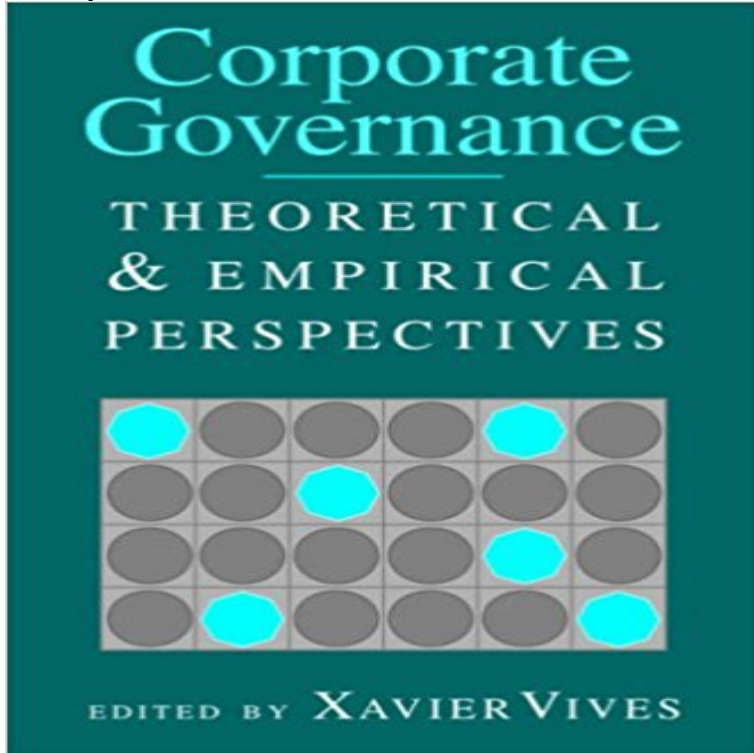


Corporate Governance: Theoretical and Empirical Perspectives
