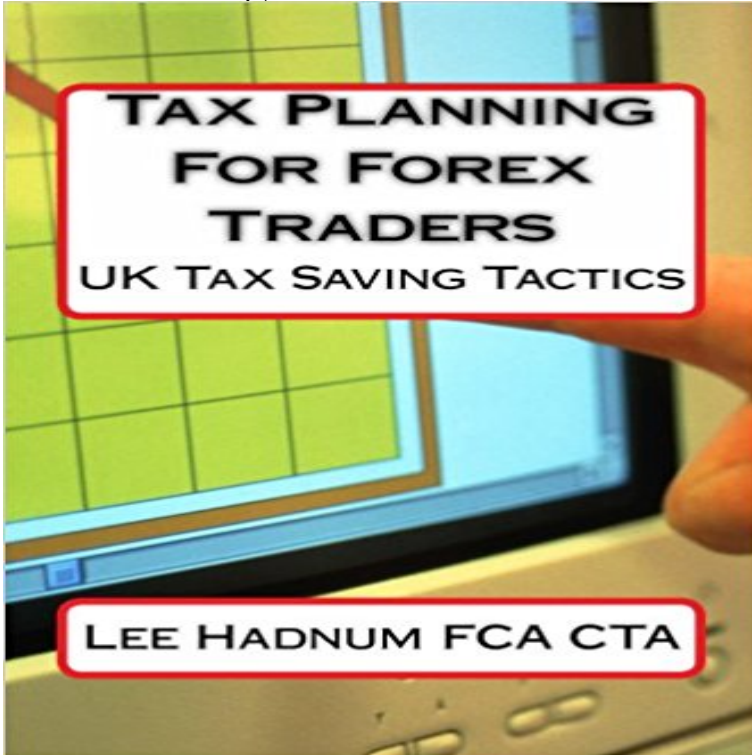


# Tax Planning For Forex Traders
