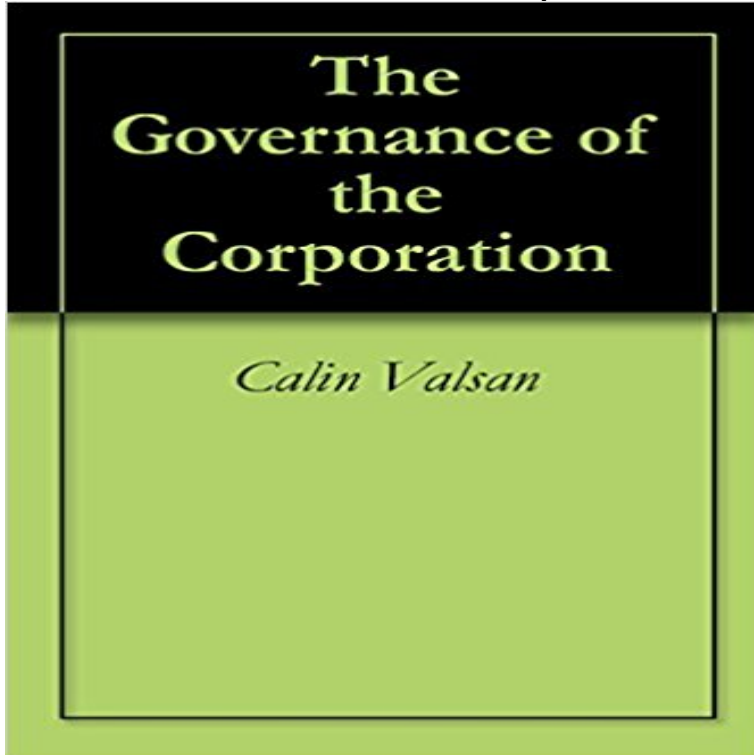


# The Governance of the Corporation
