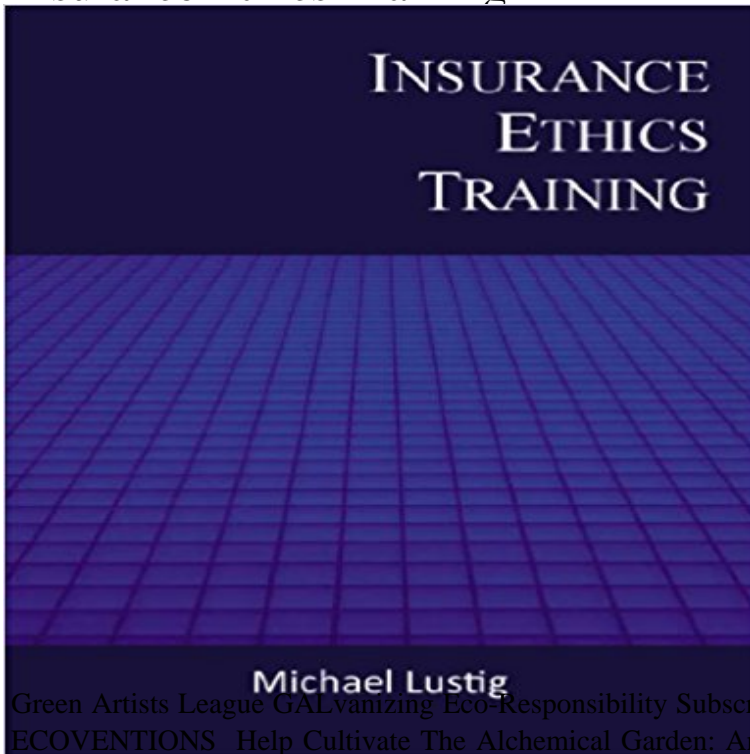


# Insurance Ethics Training
