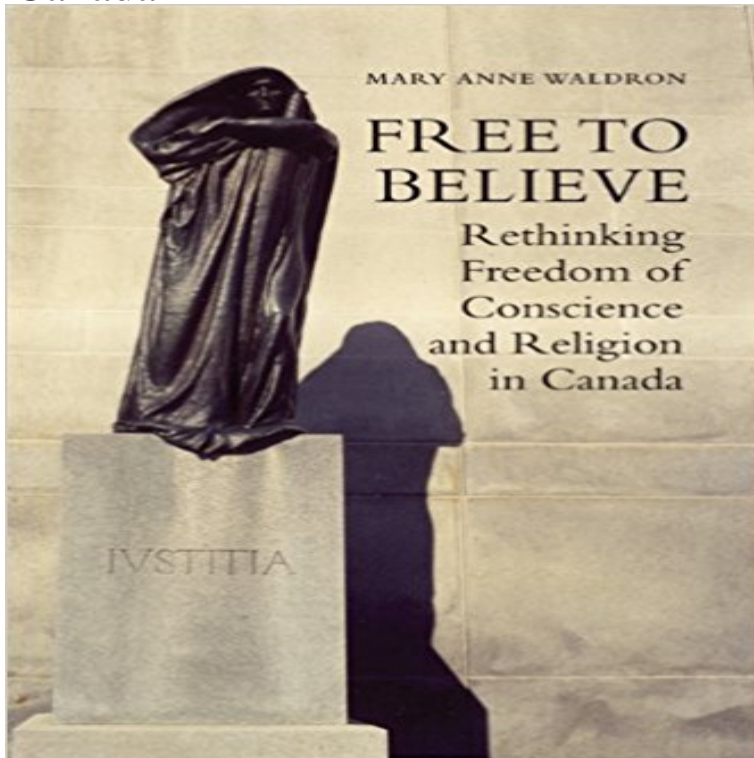


# Free to Believe: Rethinking Freedom of Conscience and Religion in Canada
