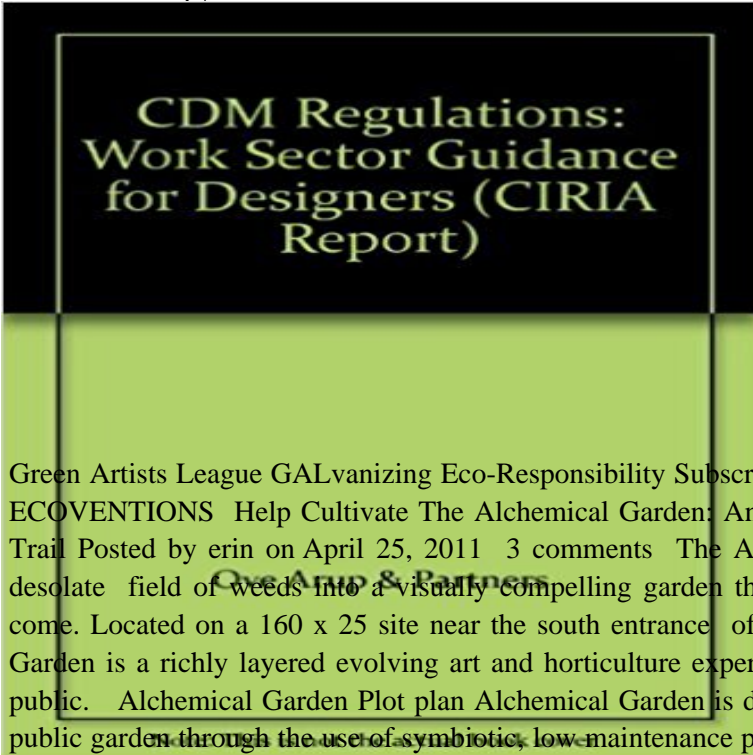


CDM Regulations: Work Sector Guidance for Designers (CIRIA Report)
