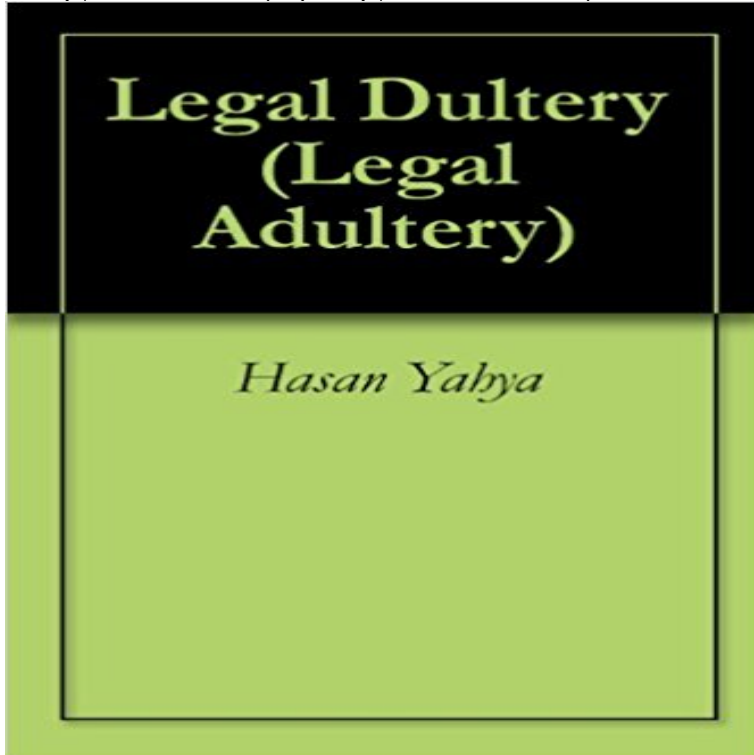


## Legal Dultery (Legal Adultery Book 1)

Sexual activities and practices of human sexuality is not simply imposed by instinct or stereotypical conducts, as it happens in animals, but it is influenced both by superior mental activity and by social, cultural, educational and normative characteristics of those places where the subjects grow up and their personality develops. Consequently, the analysis of sexual sphere must be based on the convergence of several lines of development such as affectivity, emotions and relations. In many historical eras, recovered art and artifacts help to portray human sexuality of the time period. The biological aspects of human sexuality deal with human reproduction and the physical means with which to carry it out. They also deal with the influence of biological factors on other aspects of sexuality, such as organic and neurological responses, heredity, hormonal issues, gender issues and sexual dysfunction. Sociocultural Aspects of human sexuality can also be understood as part of the social life of humans, governed by implied rules of behavior and the status quo. This focus narrows the view to groups within a society. The socio-cultural aspect examines influences on and from social norms, including media such as politics and the mass media. These sorts of media can help to bring about massive changes in the social norm examples include the sexual revolution and the rise of feminism. The book includes topics on religion and sexuality as well as an analysis of Joseph Smith and the Prophet of Islam in terms of polygamy.
